In her case she had been subjected to years of emotional and physical abuse by her mother. This strain created a toxic and oppressive environment for Gypsy. Gypsy felt like she was stuck and couldn't do anything to change her situation, which made her very sad and scared. The constant control and manipulation she endured most likely caused immense psychological distress. When she was young she was going through so much, in 2011 Gypsy tried to get away from her mother by running away with a guy she met online. When her mom found out that she wasn't in the house she smashed Gypsy computer and when she returned home she physically restrained her to her bed, gypsy also stated that her mother would sometimes deny her food and hit her... She was 19 years old at the time going through so much with her mother and her health as well. Gypsy eventually managed to get back online and she joined a christian dating site and that's where she met Nicholas Godejohn who was the man who murdered Dee Dee Gypsy's mother. She told him the truth and everything that was going on with her and her mother and ended up telling Nicholas to kill her mother so that they can be together. Later in June 2015 he went to gypsy's house and stabbed Dee Dee while gypsy was waiting inside the restroom while she was waiting she had her ears covered. She most likely didn't want to hear the tragic incident that was just about to happen right outside... Agnew's theory helps explain why someone in Gypsy's position might turn to such drastic measures when feeling overwhelmingly trapped and desperate.

The case I picked for step 1 was the Gypsy Rose Blanchard case. I chose that case because it was very interesting and I wanted to know and dig deeper into that case. The Gypsy Rose case is a really intense story.
