AMERICAN GOVERNMENTAL STRUCTURE

 - <u>Federalist structure</u> no national police force
 - Approach to law enforcement is unique in the world, reflecting the our federalist government
 - Law enforcement is primarily the responsibility of local governments (local control) and regulated at the state level



PUBLIC SAFETY ORGANIZATION

- Review reading: Local Police Departments, 2016
 - The public safety industry operates on all governmental levels
 - There are approximately 18,000 law enforcement agencies in the U.S.
 - Most police agencies are operated at the local level of government under local control (cities, towns, villages, counties, etc.)



STATE LAW ENFORCEMENT




- State Law Enforcement

INTERNATIONAL POLICING

Interpol

- International Criminal Police Organization
- Worldwide organization established for the development of cooperation among nations regarding common police problems
- Police officials of any member country may initiate a request for assistance on a case that extends beyond their country's jurisdiction.
