#### Hidden Desires

"Literature is the art of discovering something extraordinary about ordinary people and saying with ordinary words something extraordinary." In literature, writers can use words to express essential truths about humanity. The shift in Mrs. Mallard's perspective is extraordinary because she is internally scaring herself with the joy of her husband's death and embracing the new idea of independence, which is different for ordinary women during the 19th century. For instance, as Mrs. Mallard is gazing out the window, she whispers, "Free! Body and soul free!" (Chopin). Moments later she moves from the window, "Then was a feverish triumph in her eyes, and she *Beautiful choice of quote* carried herself unwittingly like a goddess of Victory" (Chopin). Figurative language is used in the representation of Mrs. Mallard's extraordinary change as she breaks free from the traditional restraints imposed on her as a wife. Mrs Mallard is accepting the sense of liberation, and empowerment, and is a new woman.

Kate Chopin is a key figure in feminist literature and is known for exploring human emotions and challenging societal standards. Born on February 8, 1850, in Louis Missouri, Chopin's literary career began after the death of her husband in 1882. As a widow with six children, she turned to writing to cope with her financial struggles while simultaneously running her family's business. In 1884, she had an affair with a married man, Albert Sampite. Slowly through Chopin's experiences, she began gathering materials for the literature she would later go on to write. Her writings frequently look deeper into the inner lives of ordinary women, highlighting the complexities of their feelings and desires in a society that expected them to conform to prescribed roles.
