Abstract

Introduction

Also making teachers be more passionate and affectionate toward their students knowing it can save a life and make a huge difference. Statement Of the Problem

The problem of child neglect at homes and schools have been extensively documented such as Hawaii, Illinois, New York and Virginia. since 1874. Child neglect at home starts when a parent fails to not respond to their child's need or desires to abuse their child physically and mentally blaming them for their existence. Once neglected children enter school signs of academic difficulty quickly emerge and antisocial behavior starts to happen in which they no longer trust an adult nor their surroundings. Children all over the world are being affected by this issue. According to Jones, Finklehor, and Halter (2008) states that "In 2006, child protective agencies received an estimated 3.6 million referrals involving the alleged maltreatment of 6 million children". In the United of America Children aren't able to communicate or trust an adult due to the fact that they can't express how they feel. In schools teachers are given a guiding principle on dealing with child neglect, but half of these teachers have been trained or dealt with these situations in which they aren't emotionally or physically involved. This issue needs to be addressed now. We don't want anymore kids to die and be blamed for their existence when it isn't their fault that we failed them as parents and as teachers. According to Garbiel Fernendez Teacher she stated that "When Garcia asked Gabriel what had happened, the boy said that his mother had shot him in the face with a BB gun. Garcia also said that, in a separate incident, Gabriel had told her that he'd been beaten with a belt, which resulted in him bleeding." A mistake we all make is never believing our students and never being able to analyze them . If I were a teacher I would take action into my own matter and do what I believed was right. I would have called the police authority and made awareness of the situation going on even and contacted other people for help. But Gabriel died when he was 8 years old and his mother shot him and called the police saying he fell while showering. What could have been different as a teacher and parent. Where was the teacher to help this child when he came to school bruised up? Where was the principle at? Where were the other parents taking note of this matter? But mostly where was our community? The intervention needed to avoid these situations would be analyzing our students more often. Having more teachers visit homes. Start training teachers to be more aware of child neglect in homes and schools. Offering family therapy and making teachers and parents more aware of their surroundings. It could be anyone kids and every life matters. Actions needed to be taken in order to protect those children in need. It would be anyone's child suffering that way. Imagine an innocent child being neglected at home and school suffering by itself. What would you do differently to protect them? But mostly what would the teachers and parents do differently?

He was 8 years old when his mom shot him to death and called the police to say that her son fell down the shower and isn't responding. The community has failed him from never

paying attention and ignoring the signs. In the article it states how the teacher saw him bruised but rarely questioned about it. Where a social worker was being manipulated by the mom. And the security guard who just looked at him but didn't bother to call. He was kept in a box eating cat poop and litter. The intervention needed was for his surroundings to be aware of what is going on. For teachers to acknowledge their surroundings. How many more children need to die in order for us to take action. How much dirt do we have to hold?

The article titled, "Child Abuse and Neglect in the Home", Kelly Dedel talks about the serious problem of child neglect in homes and school by analyzing local child that had maltreamtnt problem. Furthermore, make a website to offer a variety of parenting publications. We aren't alone in this; we are humans that make mistakes and want to learn to be a better person. And we as teachers should make a difference in our world and make it a safe place and environment for our children.

Another action I would take is Hold a Blue Ribbon Campaign involving all the community. In 1989 Bonnie W. Finnet of Vigina told people the tragic story of the abuse her grandchild had and resulted in death. And choose the color blue to remind herself of the bruised body. This would create and spread awareness all over schools, communities and homes. We will even find new and innovative ways to support families who are in desperate need of help and children that need to be saved. Our advocacy plan is to help everyone in need. Make teachers, family, and our community aware of this situation that has been happening. We don't want to fail Garbiel Fernandez nor have a situation similar in which his teachers, social services, community and even the police failed him. Using the Blue Ribbon Campaign would help children like Garbiel, Anthony and Emily have their justice and never let a child be abused or neglected anymore.

Commentary
