Topic A

Write an essay in which you discuss the relationship between two characters in *Oedipus the King.* Be sure your essay has a **thesis** (central idea) as you explore how the characters' personality, behaviors, beliefs and values affect their interaction. For example, you might discuss the interaction between Creon and Oedipus, comparing/contrasting their personalities and values. In the introduction, identify the characters and the main point you want to make about them. In the body paragraphs, you will focus on the characters and how they interact, keeping a constant eye on your **thesis** (central idea) then show their interaction. *Be sure to include at least three quotes from the play, using special citation required for this play.*

Topic B

Discuss how *Oedipus the King* meets the standards for tragedy set out by Aristotle in the **following quote** from his work *Poetics: "Tragedy is an imitation of an action of high importance, complete and of some amplitude; in language enhanced by distinct and varying beauties; acted not narrated; by means of pity and fear effecting its purgation of these emotions." Please discuss this specific quote and not other definitions of tragedy. Do not consult online sources for this assignment. This is an exercise in critical thinking and analysis.*
